2. APCO Membership is on an annual basis from 1 July to 30 June:
 - a. New members: the fee will be pro-rated from the date the Membership Form is signed.
 - b. Members ceasing membership: full payment is required for the last year of membership and partial refunds are not provided.
- 3. Annual Turnover Declaration:** The Turnover Declaration Form will be issued to the listed Executive Contact's email address on your APCO Membership. Fees relating to FY27 will require members to submit their Annual Turnover Declaration by 31 May 2026.
- 4. Payment Terms:** Payment is due within 30 days of the invoice date.
- 5. Withdrawals:** Brand Owner and International Affiliate members that have withdrawn and wish to rejoin may incur a \$350 administration fee. There is no fee for covenant supporters wishing to rejoin. There is no fee if a Brand Owner or International Affiliate rejoins after not being a member for 5 years or more
6. Access to the Australasian Recycling Label (ARL) program is currently free of charge to APCO Members.
